<b>Monday, October 12, 2020, 05:00 PM</b>	- Online Nominations CLOSE
<b>Wednesday, October 14, 2020</b>	- Scrutiny of Nominations and declaration of the eligibility of the candidates.
<b>Friday, October 16, 2020, 05:00 PM</b>	- Withdrawal of the Nominations CLOSE
<b>Monday, October 19, 2020, 08:00 AM</b>	- Online voting OPEN and LIVE
<b>Thursday, October 29, 2020, 12:00 PM</b>	- Online Voting CLOSE
<b>Friday, October 30, 2020, 06:00 PM</b>	- Counting of votes in the presence of nominees of the candidates. The venue and address will be communicated to the candidates prior to the counting date
<b>Saturday, November 07, 2020, 08:00 AM</b>	- Elections results will be declared during virtual general body meeting.

**Note:** Filing of Nominations will be online and will open on **October 01, 2020, 08:00 AM** and close on **October 12, 2020, 05:00 PM**.

### **Eligibility Criteria:**

**President Elect:** The President Elect shall be a Life Member of 15 years of the Indian Academy of Neurology and should have served in the EC in any capacity for a minimum period of three years. The term of the President Elect will be for one year. At the end of one year the President elect would automatically assume the office of the President.

**Secretary and Treasurer:** For the post of Secretary and Treasurer, the candidate should be Life Member of the Indian Academy of Neurology at least 10 years. Applicants for the posts of Secretary and Treasurer should have served in the IAN Executive Committee for a minimum period of three years.

**Editor, Annals of Indian Academy of Neurology:** Only Life members on the Indian Academy of Neurology can file nominations

**Executive Members and CME Convener:** Only Life Members of the Indian Academy of Neurology can file nominations.

**Canvassing:** Candidates seeking election for any post shall not canvass support by issuing an appeal soliciting votes or casting aspersions on a candidate or by collecting votes personally. Complaints, if any, about canvassing or malpractices should be made by the complainant in writing to the President and the Electoral Officer. These two officers shall decide upon the most appropriate course of action through mutual consultation. Final judgment rests with the Electoral Officer (President- Elect).
